## **SECTION 4: First aid measures**

## 4.1. Description of first aid measures

#### **General information**

Remove contaminated soaked clothing immediately. In the event of persistent symptoms receive medical treatment. Take away from danger area and lay down affected person.

#### After inhalation

Move to fresh air in case of accidental inhalation of vapours. If you feel unwell, seek medical advice.

## After contact with skin

Wash off with soap and plenty of water. Consult a doctor if skin irritation persists.

Vapours are heavier than air and spread along ground. The vapour/air mixture is explosive, even in empty, uncleaned receptacles. Cool containers at risk with water spray jet. Fire residues and contaminated firefighting water must be disposed of in accordance with the local regulations.

## 6.1. Personal precautions, protective equipment and emergency procedures

In case of vapour formation use respirator. Use only explosion-proof equipment. Avoid contact with skin, eyes and clothing. Ensure adequate ventilation. Use personal protective clothing.
